• INTERNATIONALLY:

By supporting international and regional justice and human rights mechanisms with niche expertise during crucial phases of an investigation, and by promoting the inclusion of marginalized victims and survivors.

• DOMESTICALLY:

The scale of the crimes affecting children in armed conflicts and fragile settings is immense, but too often overlooked. To change this reality, JRR systematically deploys experts to help its partners adopt a child-sensitive approach to their investigations and justice efforts.
